What is the overall <a href="#">deductible</a> ?	\$1,750 person/\$3,500 family. Doesn't apply to preventative care. For non-participating providers \$3,500 person/ \$7,000 family.	You must pay all the costs up to the deductible amount before this plan begins to pay for covered services you use. For your policy, the deductible starts over September 1st. See the chart starting on page 2 for how much you pay for covered services after you meet the deductible.
Are there services covered before you meet your <a href="#">deductible</a> ?	Yes.	Some covered services may be paid prior to meeting the <a href="#">deductible</a> . See the chart starting on page 2 for how this plan pays different kinds of <a href="#">providers</a> .
Are there other <a href="#">deductibles</a> for specific services?	There are no specific deductibles.	
What is the <a href="#">out-of-pocket limit</a> for this plan?	For participating providers \$3,500 person/ \$7,000 family For non-participating providers \$7,000 person/\$14,000family	The <a href="#">out-of-pocket limit</a> , sometimes referred to as the <b>Maximum Out Of Pocket (MOOP)</b> is the most you could pay during a coverage period (usually one year) for your share of the cost of covered services. This limit helps you plan for health care expenses.
What is not included in the <a href="#">out-of-pocket limit</a> ?	Premiums, difference between billed and allowed amounts, health care this plan doesn't cover, and ineligible expenses.	Even though you pay these expenses, they don't count toward the <a href="#">out-of-pocket limit</a> .

If you use an in-network doctor or other health care <a href="#">provider</a> , this plan will pay some or all of the costs of covered services.
