NOTICE IS HEREBY GIVEN THAT THE GENERAL MUNICIPAL AND SPECIAL SCHOOL BOND ELECTION WILL BE HELD ON TUESDAY, NOVEMBER 2, 2021

Voting Registration Deadlines and Important dates.

If you have **moved** or **changed your name**, you will need to re-register to vote.

- October 12** Ballots mailed out to all active/eligible registered voters.
- October 22** Last day to register to vote by mail, in person, or electronic, 5 P.M.
- October 26** Last day to request an absentee ballot.
- November 1** By mail **MUST BE POSTMARKED.**
- November 2** Polls open from 7:00 A.M to 8:00 P.M.

IRON COUNTY IS A BY-MAIL COUNTY. Ballots will be mailed out to eligible voters on October 12, 2021. Voters must be of legal voting age, citizens of the United States, and resident of the voting precinct in which they are registered. If you have re-registered by the above deadlines, we will mail you a ballot to your new address.
